1. Presentation by SANAD hospice for palliative care

| <ul style="list-style-type: none"> ➤ Sanad hospice for palliative care gave a presentation about their services for palliative care, which include mental health services. ➤ Sanad is a 7 years old independent, nonprofit NGO offering palliative hospice care for terminal ill patients and their families. ➤ It comprises of a multidisciplinary team including physicians, nurses, psychologists, research officers and volunteers. ➤ In addition to hospice care, SANAD also does research and outreach and awareness. ➤ Patients are either referred to SANAD by their doctors or through the community and social network. ➤ SANAD also offers support to the families of terminally ill patients and helps them throughout this painful transition through grief support groups. ➤ So far these support groups had been exclusively for families of patients receiving palliative care from Sanad, but the NGO is currently preparing for opening these groups to the public. ➤ It was highlighted by the MOPH National Mental Health Programme that “persons receiving palliative care” are one of the vulnerable groups identified in the national mental health strategy as needing special attention when it comes to mental health.
