This notification is to inform you of an urgent voluntary recall of the following:

An internal finding identified the presence of pinholes/cuts in some of the tyvek pouches of the vacuum tubing sets included as an accessory to these products. As a result, there is a potential for the pouch integrity to be compromised, which may result in compromised sterility of the product. If the compromised product is used in surgery there is a potential risk of infection for the patient.

A review of our records indicates that you have received one or more of the units affected by this recall. Consistent with this voluntary recall; we are requiring the return of all of the products as listed in **Attachment 1** in this notification.

Please examine your inventory immediately to determine if you have any of the products listed. If so, please remove the affected products and place in a secure location.

This voluntary recall only affects the products listed; no other products are affected by this voluntary recall.

You must acknowledge receipt of this notification by completing and faxing back the attached Field Action Response form, whether or not you have any affected products.
