Urgent Field Safety Notice

Occlutech LAA Occluder

Type of action: Field Safety Corrective Action

Dear customer,

We are writing to inform you of a product problem that we have identified with the Occlutech LAA Occluder and provide you with the actions that need to be taken immediately to address the issue. These actions are being taken in response to individual reports that we have received, that indicate an increased level of patient risk with the use of the Occlutech LAA Occluder.

ACTIONS TO BE TAKEN BY THE CUSTOMER

- Identify all patients that currently have an Occlutech LAA Occluder implanted and schedule a clinical follow-up to confirm correct placement of the device.
- 2. Continued follow-ups should be performed as described in the current labeling: at 1 month, 3 months and 12 months after implantation.

Problem description	Within the LAA trial and commercial use four dislocations have occurred with Occlutech LAA Occluder. The dislocations occurred both during the procedure (after initial release of the device) and at some point in time after the clinical procedure was completed (Follow-up Phase). Our initial review of these cases clearly indicates that an implementation of a more extensive operator training program and clearer guidance is needed to prevent comparable situations in the future.
