Dear Device Customer/Distributor,

Smith & Nephew informs you of a voluntary Field Safety Corrective Action (FSCA) in relation to the Sterile RENASYS° Transparent Film and the RENASYS° Dressing kits that contain the folded RENASYS° Transparent Film. The folded Sterile RENASYS° Transparent Film is used in with Gauze Dressing kits and is intended to be used in conjunction with Smith & Nephew Negative Pressure Wound Therapy (NPWT) Systems.

Smith & Nephew have identified seal integrity failures on the folded Sterile RENASYS° Transparent Film pouches during transit testing. All the seal integrity failures identified during the testing occurred at the point where the Sterile RENASYS° Transparent Film pouches were folded during the packaging process.

Smith & Nephew have identified that the process of folding the Sterile RENASYS° Transparent Film pouch during its packaging has the potential to damage the pouch seals resulting in a loss of sterility of the product. The loss of sterility has the potential to contribute to a local infection.

To date Smith & Nephew is not aware of any complaints reported in relation to this issue.

The scope of this FSCA is <u>only</u> limited to the folded sterile RENASYS° Transparent Film and the RENASYS° Gauze kits that contain the folded sterile RENASYS° Transparent Film. The scope of the FSCA <u>does not</u> extend_to the other Dressing kis and components of the RENASYS° NPWT Systems. Figures One, Two and Three illustrate examples of the affected items in this FSCA.

The purpose of this Field Safety Notice is to provide information to identify the affected items and to communicate the necessary actions to be undertaken by customers and distributors.

Details on affected devices:

The affected folded Sterile RENASYS° Transparent Films in scope of this FSCA are sold as either an individual item or as part of the RENASYS° Gauze Dressing kits. The affected RENASYS° Transparent Film supplied as an individual item or as part of the RENASYS° Gauze Dressing kits are detailed in Annex One.

Figure Four illustrates the location of the Part Number and Lot Number of the affected folded Sterile RENASYS° Transparent Film supplied as a separate item.

Figures Five and Six illustrate the location of the Part Number and Lot Number of the folded Sterile RENASYS° Transparent Film supplied as part of the Gauze Dressing kits.




Figure Four – Location of the Part Number and Lot Number of the affected RENASYS° Transparent Film supplied as a separate item






Figure Five – Location of the Part Number and Lot Number of the Gauze Dressing kits where RENASYS° Transparent Film is supplied.




Figure Six – Location of the Part Number and Lot Number of the Gauze Dressing kits where RENASYS° Transparent Film is supplied.



Description of the problem:

Smith & Nephew have identified seal integrity failures on a small number of folded Sterile RENASYS° Transparent Film pouches during transit testing. All the seal integrity failures identified during the testing occurred at the point where the Sterile RENASYS° Transparent Film pouches were folded during the packaging process.

Smith & Nephew have identified that the process of folding the Sterile RENASYS° Transparent Film pouch during its packaging has the potential to damage the pouch seals resulting in a loss of sterility of the product the loss of sterility has the potential to contribute to a local infection.

To date Smith & Nephew is not aware of any complaints reported in relation to this issue that has led to a local infection.

Upon the identification of the root cause, Smith & Nephew have implemented appropriate corrective actions.



Actions to be taken by Customers and Distributors

No. Actions to be undertaken Identify users of the affected folded Sterile RENASYS° Transparent Film and the RENASYS° Gauze Dressing kits that contains the folded Sterile RENASYS° Transparent Film. This requires you to identify all users of Smith & Nephew RENASYS° NPWT systems, who may be in possession of an affected items and need to be made aware of this issue and the actions to be executed in this Field Safety Corrective Action. Users may be distributors, healthcare professionals, home care workers or patients. Provide copies of this Field Safety Notice to all identified users as soon as is reasonably practicable. 2 Users are instructed to immediately inspect the Part Number and the Lot Number for the folded Sterile PENASYS° Transparent Film and the PENASYS° Gauze Pressing kits that contains the




Figure Seven - Location of the Part Number and Lot Number of the affected RENASYS° Transparent Film supplied as a separate item







Figure Eight - Location of the Part Number and Lot Number of the Gauze Dressing kits where RENASYS° Transparent Film is supplied
