Details on affected devices:

This notice is provided voluntarily to inform you of an urgent product recall on the Anchor Drives used in both the Cardioband Mitral and Tricuspid Reconstruction Systems, product number VSU04002 or VSU05801 (region dependent). We are recalling all lots of this product at this time; a complete list of affected product is attached below.

Description of the problem:

Through the review of recent case reports, we have noted an increased number and rate of Cardioband anchor disengagement events, both during and in the days after mitral implantation. Such anchor disengagements have led, in up to two cases, to Cardioband implant dehiscence requiring intervention. A shift in the Manufacturing process for the anchors, while within our approved specification, is the primary cause of anchor disengagement.

Advice on action to be taken by the user:

Do not use your current inventory of Cardioband Anchor Drives; please return them to Edwards. Your Edwards TMTT Representative will assist with product return, and subsequent product replacement. Only the Anchor Drives are affected by this Field Safety Notice – not the entire Cardioband system.

Many patients treated with the Cardioband to date are in clinical trials; we recommend following-up those patients per their trial protocols. For patients treated outside a clinical study protocol and treated between July and December 2017, we recommend you consider echocardiographic follow-up between 3 – 6 months after implant, or sooner if symptoms warrant.

Edwards is dedicated to partnership with you and your patients on any such matter.

There is no risk of anchor embolization after disengagement; the anchors remain securely attached inside the Cardioband implant.
