Description of the Problem, Root Cause and Corrective Measures

During continuous post-market surveillance we became aware of a disconnection of the female Luer-Lock connector from the venous side of the Single-Needle adapter leading to blood loss for the patient. The dialysis machine had triggered an alarm indicating the disconnection and the incident had no consequences for the patient.

The investigation showed that the Luer-Lock connector was not glued to the tube of the Single-Needle adapter.
