Reason for Recall:

Synthes GmbH has discovered the press fit of the insert components were not properly completed during manufacturing for the lots listed above. This may result in the drive head being loose or separating from the insert for the insertion handle. If this occurs intraoperatively the intra-operative compression step will not be able to be completed.

Potential Impacts:

There is a potential harm for surgical delay if the FNS procedure was not able to be completed. Additional harms may include bone damage and damage to surrounding structures if the procedure is changed and multiple screws or a hip screw fixation being used.
