URGENT: FIELD SAFETY NOTICE - PI-21-3959

BARD® MARQUEE® Disposable Core Biopsy Instruments and Kits

Type of Action: Product Removal

Attention: Clinical Personnel, Risk Managers, Biomedical Personnel

This letter contains important information which requires your immediate attention.

Dear Customer,

BD is issuing this Field Safety Notice to remove specific lots of BARD® MARQUEE® Disposable Core Biopsy Instruments and Kits. The specific product code (REF) / lot number combinations affected by this product removal are outlined in Attachment 1. According to our distribution records your organisation may have received the impacted product.

Description of the Problem




Figure 1; BARD® MARQUEE® Disposable Core Biopsy Instrument

Through customer feedback, BD has discovered the specific lots of BARD® MARQUEE® Disposable Core Biopsy Instruments and Kits listed in Table 1 above have a potential fault in the Penetration Depth Switch (refer to Figure 1). The events that BD have received reported that the Penetration Depth Switch, depicted in the image below; used to select the desired penetration depth of tissue biopsies, detached from the device during use.

A Penetration Depth Switch detachment may result in (1) prolongation of the biopsy procedure as the user obtains a replacement device, (2) undershooting the lesion unexpectedly, compromising the sample quality and potentially leading to a misdiagnosis or (3) if the penetration is overshot, the device may pierce adjacent tissue and/or organs causing injury. Medical or surgical intervention may be required. No specific patient follow-up activities are recommended for affected devices already used to take a biopsy. However, any clinical considerations, including further diagnostic testing to ensure adequate sampling has been obtained and/or if any inadvertent injury may have occurred should be at the discretion of the medical doctor.

To date, there have been no reported patient injuries associated with the reported Penetration Depth Switch detachments.

Advice on actions to be taken by the customer:

- 1. Inspect your inventory, locate and quarantine any units of the impacted devices listed in Table 1.
- 2. If you have further distributed the product, please identify those facilities, notify them at once of this product removal and have them destroy the affected product.
- 3. Destroy any unused units of the affected product and complete the customer response form on page 3 indicating:
 - the quantities destroyed OR
 - o that your organisation does not have any impacted units left in inventory
- 4. Return the completed Customer Response Form to <u>Ahmed.Shebah@bd.com</u> as soon as possible or no later than March 12th, 2021.
