1. Presentation and review of the "Triage Criteria for Inpatient Psychiatric Hospitalization"

| <ul style="list-style-type: none"> ➤ Several challenges were raised by MHPSS actors in previous MHPSS TF meetings such as having long waiting lists for referral to admission to inpatient psychiatric care, and having discrepancies between the criteria used to determine the eligibility and urgency of the referrals. ➤ MHPSS TF objective in 2019 Action Plan: “Develop criteria for triage of persons to be admitted for psychiatric admission” ➤ During the February MHPSS TF meetings, discussions were centered around Challenges related to Triage for Referral to Psychiatric Admission faced by MHPSS TF organizations. Shortly after the MHPSS TF meetings, interviews were conducted with psychiatrists from referring organizations around the challenges faced when referring persons to psychiatric inpatient care as well as the lessons learnt from past experiences. ➤ The following first draft of the criteria are the product of these fruitful collaborations with organizations. The first draft was presented in the meeting for feedback by task force members. | <ul style="list-style-type: none"> ➤ Next steps: <ul style="list-style-type: none"> ○ The document will be sent to relevant MHPSS TF members for review. ○ Piloting of the criteria ○ Finalization and implementation of criteria |

- Aim of the criteria is to have a standardized emergency mental health triage criterion across NGOs that refer to hospital admission to:
 - Determine highest priority cases
 - Facilitate access
 - Eliminate delays
 - Decrease the risk of self-harm and suicide.

- The Triage Criteria for Persons with Mental Health Conditions in Need of Hospitalization are designed as a tool to be used by the psychiatrist in humanitarian field and public sector to support in decision-making through:
 - Providing a standardized approach to determine need and the urgency for inpatient care
 - Clarifying prioritization of referrals of persons to psychiatric admission, with the aim to ensure timely referral to needed care.
 - Ensuring that responses are appropriate to the person’s level of risk
 - Providing a structured approach to document and facilitate the process of prioritizing persons to be admitted for inpatient psychiatric care, and record the needed information for referral and follow-up
 - Providing a basis for improved communication between the mental health professionals (psychiatrists at NGOs) who do the triage and other services (psychiatrists at psychiatric hospitals).
