

URGENT VOLUNTARY PRODUCT RECALL

Johnson & Johnson MEDICAL GmbH is voluntarily recalling specific lots of LAPRA-TY™ II, PDS™ II, VicryI™, VicryI™ Plus, VicryI\* Mesh, Ultrapro™, and Ultrapro™ Plug (see Attachment 1 for listing of product codes and lot numbers). The company has identified the potential that a defect could compromise the integrity of the foil pouch which could impair the sterile barrier of the product and allow possible degradation of the absorbable implant. We have not received any reports of adverse events related to this issue. This issue was identified internally during a routine quality control inspection.

This letter is an update to letters originally sent on January 31, 2013. One additional lot of UltraPro Plug (Product Code UPPM1, Lot # EM8BQHA0) has been identified as distributed to customers.

This recall only impacts the product codes and lots listed in Attachment 1. Please only return product codes/lots listed in this attachment.

#### Effective immediately, please:

- Identify and quarantine any of the recalled products from your inventory (physical quarantine cage or other suitable restricted access area).
- Check with your customers if they still have any of the listed products in their stock. If yes, have the products sent back to you immediately.
- Fill out the attached "Recall Confirmation Form" and send the completed form to the contact provided on the form by *May 15, 2013.*
- Disposition the returned product by either:
  - Destroying all devices that the customers return to you and sending a "Certificate of Destruction" to Anke Winter (undersigned) once the returned products have been destroyed; or
  - Returning all devices that the customers return to you to:




