

14F Edwards Expandable Introducer Sheath Set, Model number 9610ES14, Lot number 59390915/intended for use with the 23mm and 26mm SAPIEN 3 Commander Delivery System in the clinical investigation, Study #2012-07, Safety and Performance Study of the Edwards SAPIEN 3 Transcatheter Heart Valve

Description of the issue:

Edwards has identified during internal testing that in some cases the 14F ESheath shaft may not expand as intended causing tearing at the liner. If this were to occur clinically, the torn liner creates a potentially rougher surface which may cause or contribute to a vascular complication during removal of the device from the patient,.

Edwards has therefore decided to recall the above lot of the 14F expandable Introducer Sheath set.

This Field Safety Notice does not pertain to the valve implant and patients already implanted are not affected by this Field Safety Notice.

Action requested:

 Our records show that you have received the affected Expandable introducer Sheath Set of lot 59390915. These devices should not be used. Please review and quarantine any affected inventory immediately. Please return all unused affected product from your inventory to Edwards.

2. The 16F Expandable Introducer Sheath Set, Model 916ES23 may be considered for use in place of the 14F Expandable Introducer Sheath Set, Model 9610ES14. The 16F device expands to a maximal diameter of 7.9mm when the 26mm Commander is passed through it. In comparison, the 14F device expands to a maximal diameter of 8.0mm. Hence, the use of the 16F Expandable Introducer Sheath Set rather than the 14F does not impact the risk associated with the transfemoral access approach.
