Recall Information

Subject:Easypump C-bloc RA OnDemandArt.-No.:4440008Batches:152803, 182313, 192472

B Braun Medical Ltd on behalf of I-Flow/Kimberly-Clark (Manufacturer) are recalling the above batches of the Easypump C-bloc RA and would kindly ask that all affected devices are withdrawn from use immediately.

I-Flow/Kimberly-Clark recently determined that in a small quantity of Easypump C-bloc RA pumps with OnDemand bolus button, the button may not lock in the down position when depressed and/or the orange bolus refill indicator may stay in the lowermost position. In this condition, the patient may receive continuous infusion at a rate greater than expected.

I-Flow/Kimberly-Clark's complaint analysis determined that approximately 0.04% of the pumps (i.e., approximately 4 out of 10,000) may develop this condition. If this condition occurs, it may not be detected during filling or priming of the pump. The use of a pump with this condition may result in over medication of the patient and may potentially result in serious patient injury.
