Abbott Medical Optics (AMO) STAR Excimer Laser System Models S3, S4 and S4 IR

Dear STAR Excimer Laser Customer:

Abbott Medical Optics (AMO) is providing this advisory notice to all customers who use the AMO STAR S3, S4 and S4 IR Excimer Laser Systems to make you aware of an issue that has an unlikely potential to result in inadvertent laser firing. This issue was identified through an in-house training exercise under specific conditions unlikely to occur in a clinical setting. To date there have been no reports of inadvertent laser firing or any injuries associated with this issue.

In AMO's ongoing commitment to safety, we will be replacing a circuit board component in your laser at your next service visit at no additional cost to you. You may continue to treat patients with your laser. AMO has not identified any records of an inadvertent firing of the laser associated with this issue. In the unlikely event that you believe the laser system is initiating a treatment without your direct input, immediately press the Laser Stop button located on the doctor's panel per the instructions contained within the Star Operators manual located in sections titled "General Precautions" and "Turn System Off in Emergency".
