Potential movement of needle positioning device if safety switch is not locked properly

Dear customer,

This letter is to inform you of a potential malfunction and hence potential risk to patients when using a stereotactic biopsy device on the Mammomat Inspiration mammography system.

When does this malfunction occur and what are the potential risks?

The stereo biopsy devices (serial numbers see attached list) for Mammomat Inspiration mammography systems might have integrated a safety switch which causes a failure of the functionality. The pin implemented in the safety switch may not put enough pressure on the safety circuit to prohibit movement. The needle positioning device may move even with the safety switch being set sideward. If this occurs with the needle being already inserted, it could lead to an unintentional patient injury.

What steps can the user take to avoid the potential risk of this issue?

To avoid injury of the patient please carefully follow the instructions in the user manual – chapter safety switch:

To ensure proper functioning, the biopsy unit safety switch must be inspected every day it is used:

- o After the biopsy unit is mounted, you must check if you are able to rotate the safety switch to the left and to the right without any interference.
- o When the safety switch is in the center position (where movement is possible), you must be able to move the needle holder via the manual control (hand box) without any problems in the X, Y or Z directions.
- o When the safety switch is turned to the left or right (movement is blocked), you must not be able to move the needle holder via the manual control (hand box) in the X, Y or Z directions.
- o When the safety switch is moved to the manual override position, it should automatically return to the left or right position.
- o If one of these steps cannot be performed, please contact Customer Service.
- We recommend to inspect the safety switch <u>before every biopsy</u> until the problem is solved.

In case the needle holder moves unintentionally, please press the emergency stop.

How will the issue finally be resolved?


Siemens is preparing a modification of the safety switch that will resolve this potential malfunction. The field modification will be available beginning of October.


